





The transaction is Aptiv's largest since it was spun out of Delphi in 2017. The company states it will help it capitalize on the shift to software-oriented vehicles, and also diversify its revenue. Wind River has now transacted multiple times, since being acquired by Intel for \$884M in 2009, then spun off to TPG in 2018 for an undisclosed value. You can read the Aptiv investor relations presentation of the deal here. The deal is expected to close in mid-2022. (The author previously worked at Wind River, 2001-03 and also has worked with them on buy-side advisory when the company was part of Intel.)

Mirametrix is an embedded computer vision AI software vendor targeting consumer electronics and automotive markets, based in Montreal. Its software focused on attention sensing and gaze tracking for applications such as Driver Monitoring Systems (DMS) and privacy. Mirametrix software can execute on any camera hardware, which makes it highly scalable across many markets.

TWENTYBN ACQUIRED BY QUALCOMM

DEAL METRICS: \$25M ● >10X REVENUE MULTIPLE

CONNECTED VISION'S VIEWPOINT

Twentybn is a provider of sports fitness behavior vision edge analytics software. It had built a deep learning database of 4 million annotated video clips, supporting 2,600 human behaviors and >50 exercises. The solution ran on simple RGB cameras, which made it scalable across many platforms. Ultimately, twentybn received interest and offers across the AI software, exercise electronics and semiconductor industry, and sold for a significant revenue multiple.

Jiffy.ai's enterprise software platform brings AI, ML and natural language processing to business users with a no-code platform. As AI platforms become more powerful and sophisticated, they also become more complicated and require more expertise for business users. No-code AI platforms are in demand because they enable enterprises to take advantage of advanced AI-driven capabilities without having to hire a team of PhDs to implement.

CONNECTED VISION'S VIEWPOINT

Raspberry Pi raised \$45M in growth equity in September 2021. The company is widely expected to perform an IPO in 2022 in the \$500M valuation range. Last year Raspberry Pi made a profit of \$15M on sale of 7.1M devices. We view the company's success as a positive sign to similar companies such as Arduino¹, which focuses more on the embedded microcontroller market.

The company has over 500 paying customers including Cisco, Akamai, GE, Microsoft and Walmart. Timescale has steadily grown to unicorn status since raising its Series A in late 2017.




