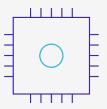

ARE CHIP COMPANIES STILL BUYING SOFTWARE COMPANIES? YES





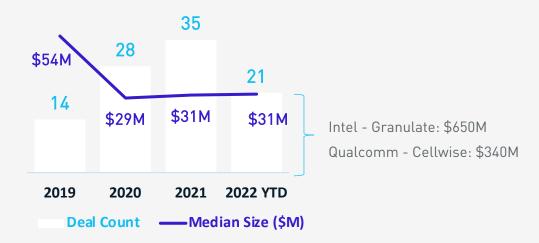
Semiconductor companies remain good buyers for software companies. At CVA, we spend a great deal of time talking with semiconductor executives, who may be buyers or strategic investors for our clients. Everyone on our team spent decades in the semiconductor and related industries before becoming bankers. We also have deep transaction experience, advising deals selling clients to buyers including Renesas, Qualcomm, Lattice Semiconductor; and the Arduino Series B with strategic investors including Renesas and ARM.

From a macro level, we see these trends:

- Transaction counts peaked in 2021 (as expected) but have remained above 2019 levels.
- Average transaction values have held constant from 2020 2022 in the \$30M range¹
- Overall, software acquisitions by semiconductor buyers have remained strong in 2022

CHIP COMPANY DESIRED SOFTWARE ACQUISITIONS



AI/ML modeling and inference engines that enable high performance AI software at the edge, on low footprint edge processors without a GPU. Based on PyTorch, TinyML, TensorFlow. We've also seen interest in a broader range of AI-based software such as Natural Language Processing (NLP).



Computer vision technologies that strengthen camera and imaging differentiation in competitive markets like smart phones, security, automotive (attention-sensing, navigation and in-cabin monitoring), and automation. Technologies with facial recognition should be GDPR compliant, as privacy concerns accelerate.



Expert software teams in high-demand disciplines like computer vision and AI modeling. Despite hiring slow-downs, engineers with expertise in AI/ML and automation remain in high demand. Many chip buyers are seeking to build centers of excellence outside of Silicon Valley in places like Montreal.



Acquisitions that enable high volume design-wins in markets like automotive, mobile and industrial. As the market becomes more uncertain, companies with more customer footprint and revenue will be more in demand.



Large global ecosystems of developers that are generating applications, code base, thought leadership and loyalty. These ecosystems create more pull-through design-wins.

DEAL METRICS: NR ● >>10X REVENUE MULTIPLE

Steradian Semiconductors is an India-based provider of 4D radar imaging semiconductors, which is targeted towards automotive navigation. The deal represents another significant transaction for Reneses since 2021, which has included investments in Arduino (Arduino Series B was advised by CVA professionals while affiliated with a previous firm), and Syntiant; and acquisitions of Dialog Semiconductor, Celeno and Reality AI.

VESPER ACQUIRED BY QUALCOMM

DEAL METRICS: \$160M

Vesper is a developer of piezoelectric microphone products designed to improve the reliability of voice in smartphones, smart speakers and similar devices. The company had recently completed an \$18M Series B (post-money of \$143M), closing in December 2021. Qualcomm continues its strong pace of M&A, acquiring 9 companies since 2021 including RoadDB, Cellwize, and Twentybn. (Twentybn advised by CVA professionals while affiliated with a previous firm).

SIERRA WIRELES TO BE ACQUIRED BY SEMTECH

DEAL METRICS: \$1.2B ● 2X REVENUE MULTIPLE

Semtech sells analog and mixed signal semiconductors across broad markets, with revenue generated primarily in Asia. The acquisition will strengthen Semtech's IoT offerings. Semtech has been historically active in minority growth equity investments in companies like Dryad, Microshare and myDevices.

Metalenz is a developer of optics designed for high-volume applications including consumer electronics, mobile and automotive. It enables customers to provide high-resolution full-color imaging in a smaller & flatter form factor. The company's technology was built at Harvard University.

INVESTORS: Belden, undisclosed others. Previous investors include Mitsubishi

Litmus has developed an intelligent edge computing platform for IoT, primarily in the manufacturing sector. The platform facilitates connectivity to hundreds of OT assets and legacy systems. The Series B brings Litmus total funding to \$43M. Belden continues a run of strong activity since 2021, which also included 4 smaller acquisitions totaling \$160M.

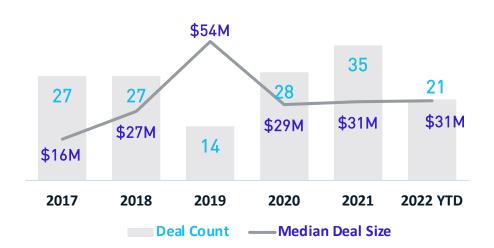

Esperanto offers energy-efficient computing semiconductors for AI / ML, based on the emerging RISC-V instruction set. Dave Ditzel, CTO was previously the founder and CEO of Transmeta.
